All participants could hear, communicate, and participate with each other concurrently and before the board. The identities of all participants were verified as true. A quorum was met, and all board votes were taken/ cast by Executive Board members only.

- 1. Call to Order- meeting called to order at 6:17p.
- 2. February Meeting Minutes Approval- Minutes motioned, motion was seconded and unanimously approved.
- 3. Treasurer's Report
 - a. Payments- payment has been mailed for four AS tournaments. Payment was given to SCLL for Spring and 2023 Fall Snack Bar (SB) buyouts.
 - b. We will request a SB costs breakdown from SCLL.
- 4. President's Report
 - a. Bylaws & General Membership Meeting
 - i. Continued convo about suggested amendments- It recommended to have two separate voting bodies; the "general membership," and the "manager membership." This recommendation was motion, seconded and approved.
 - 1. It was recommended that an amendment be redefined in the bylaws for the "General Membership." This recommendation is as follows; "The General Membership shall consist

of each family with a child registered with the Navajo Girls Fastpitch Softball. Each family shall be entitled to one vote at general meetings." This recommendation was motioned, seconded and unanimously approved.

- 2. It was recommended that an amendment be added to the bylaws stating that the Executive Board of Directors shall be elected by the Manager's Membership, with voting in person or electronically, and such election shall be held on or prior to the last day of Spring recreation season. The nominating committee shall give reasonable notice (note less than 10 days) prior to the vote. All nominations shall be confirmed by the nominee prior to placement on the ballot. This recommendation was motioned, seconded, and unanimously approved.
- ii. General Membership Meeting- An email will be distributed before the end of the month to the current general membership for voting on the recommended bylaw amendments.
- b. General updates
 - i. Right of Entry permits- Right of Entry permits with Alyssa at the league's Parks and Rec department, and it was requested that the addition of field tarps be stored on the fields.
 - ii. SDSS permits/ lights- Alyssa was contacted about bringing in lights for the SDSS tournament, but until we receive permission for lights, a permit will not be submitted. SDSS permit updates were tabled for April's BOD meeting.
- 5. VP's Report
 - a. Post- DST schedule- all games scheduled will have a 30 min window between them. This is so that the 6u Minis field practices will not interfere with pre-game warm ups. If any issues arise, 6u practices can also be moved to Hearst for the remainder of the season.
 - b. Rain-out Games- if managers would like to play a make-up game, they can schedule with their original opponents during Spring Break, or work with their normal practice day if there aren't any conflicts. Managers will be contacted with these details.
